### A. Comprehensive Plan Survey-Preliminary Results

Staff updated PRAC on the Comprehensive Plan Survey. The survey has been marketed through the *Jordan Independent*, the City's Facebook page and web site, through a direct mail with the City's newsletter, on City utility bills and at Celebrate Jordan. As of February 6, 2016, 274 surveys were submitted. Of these 267 indicated they are residents of Jordan. According to the 2010-2014 American Community Survey 5 year estimates through the Census Bureau, there were 2,153 households in Jordan in 2014, suggesting a response rate of approximately 12.4% of Jordan households. Drawings for four \$25 Jordan Chamber Bucks prizes were included as an incentive for participation in the survey. Many participants provided additional comments for each questions. These will be provided as a part of the discussion for the chapter to which the topic pertains (i.e. Parks and Trails).

# B. Lagoon Park Shelter- Lions Donation- update

Staff presented an update on the Lagoon Park Shelter. A grant application was submitted to the DNR for the Outdoor Park and Recreation on March 29, 2016, as approved by the City Council. The application included a project cost of \$88,725 which included \$7500 of in-kind labor costs for Public Works to provide construction management, \$2500 for removal of the existing shelter and \$1400 for the building permits. The Lions have offered to pay for \$20,000. The requested grant was for \$44,362.50, leaving \$24,362.50 as the city's share. No Motion Needed

Staff reached out to Signature Graphics and Fast Signs for estimated costs for the signs but only got the estimates from FastSigns.
