3. Management Report

A. New EDA Member Application

Planner Barbes presented the application of Ryan Dahnert for a new EDA board member. The EDA Board then reviewed the application and asked Mr. Dahnert questions about the EDA and why he would like to serve. Jabs asked “what do you see Jordan is lacking and what do you think the City has done well?”

Ryan answered “There is a small town feel we have enjoyed everyone we met and there are many amenities within a short drive. I think we should try and look at different ways to engage the commuters within the Community.” Dahnert also said Tax Abatement and TIF are important tools the City has to help bring in new industry and that he found out about the position via Facebook. The Board thanked Dahnert for the interest it would complement our group and help bring in new blood and ideas. Planner Barbes also updated the EDA this is the only current application and the position has been open for 3 months.

Motion Mike Franklin second Ray Sandey to approve Ryan to recommend the apportionment of Ryan to be on the EDA. Oppose: None. Motion approved.

B. Internal Matching Grant Application 213 Broadway St

Andrew presented the Internal Grant application for 213 Broadway Street and explained the policy the amount being requested would be the 2-1 match request of \$1,305. The building has two commercial on the downstairs and the upstairs has two apartments. The grant would be used to upgrade the electrical within the building.

Motion Ray Sandey second Dan Elke to approve B. Internal Matching Grant Application 213 Broadway St for \$1,305. Oppose: None. Motion approved.

C. Downtown Façade Matching Grant 226 Water Street

Andrew presented the Facade Grant application for 226 Water Street and explained the policy the amount being requested. The building will be used for 350 SQFT independent office space in the front and 150SQFT in the backside of the building. The design review will happen at the Oct 5th Planning Commission special meeting. The request is for a matching grant not to exceed \$5,000.

Motion Dan Elke second Dr. Chuck Cook to approve C. Downtown Façade Matching Grant 226 Water Street request for \$5,000. Oppose: None. Motion approved.

D. Report from Jordan Area Chamber of Chamber Commerce

Greg Ott Chamber liaison gave an update on the Chamber of Commerce
The Chamber Golf Event is tomorrow the 22nd. Shelly the Chamber employee is stepping down from her position she will be working with the Chamber until her replacement is found.
