5.0 NEW BUSINESS

A. Park Chapter of Comp Plan

Jo Foust presented a draft version of the Parks chapter for the Comp Plan. Commissioners discussed the review process with the chapter. They are asked to divide up the parks and conduct an evaluation of every park. Councilmember Stier asked that we review three rivers plans and reach out for possible grants for our parks. Staff noted that a community Visioning session will be set up in the future for all councilmembers, commissioners and the public can give input for future growth. Commissioners noted an interest in learning more about a community pool and directed staff to put together possible survey questions. Commissioners Vizenor and Brewster also noted the need for more green space and to work with Green Step Cities.

B. Sawmill Woods Update
