Thoughts from Chief Empey



Dear Mayor and City Council Members – I'd like to thank our City Council and our citizens for again being extremely supportive of our police department and supportive of the jobs that our Officers and staff do on a daily basis. Having strong local support provides us with a little bit of an extra jump in our step and keeps us pushing forward allowing us to always be and do the best that we are able to while serving a wide variety of citizen needs. Our Officers take great pride in contributing to the quality of life of our citizens and I am quite proud of our department. Our Officers and staff are working together as a true team,

supporting each other, and I believe positive community interactions, efficiency, and thoroughness in the wide range of services we provide to our citizens is the result. With that said however, I am also always looking and listening for new ideas, new trainings, or new innovations that can be implemented to further promote Officers and organizational growth. I believe if administrations are not always looking forward for ways to improve their organizations, they can become complacent missing opportunities for growth and improvement while negatively effecting efficiencies in overall work product.

A short statistical summary of 2018 - crimes reported within our City decreased by 17 incidents overall to total 545 in comparison to our 2017 statistic of 562 total crimes. Significant decreases were seen in theft and fraud crimes, however those decreases were mostly offset by increases in assault, narcotics, and DUI crimes.

Overall calls for service (criminal and non-criminal totaled) decreased to 7207 in 2018 from the 2017 total of 8018. Medical calls totaled 306.

Additionally, we have our first full year of statistics gathered after the passage of our Crime Free Multi-Housing Ordinance. We currently have 549 registered rental units compared to 1735 non-rental residential units. Total calls for service at residential rental units tallied 931 with 55 of those being crimes. Total calls for service at our residential non-rental units tallied 683 with 64 of those being crimes.

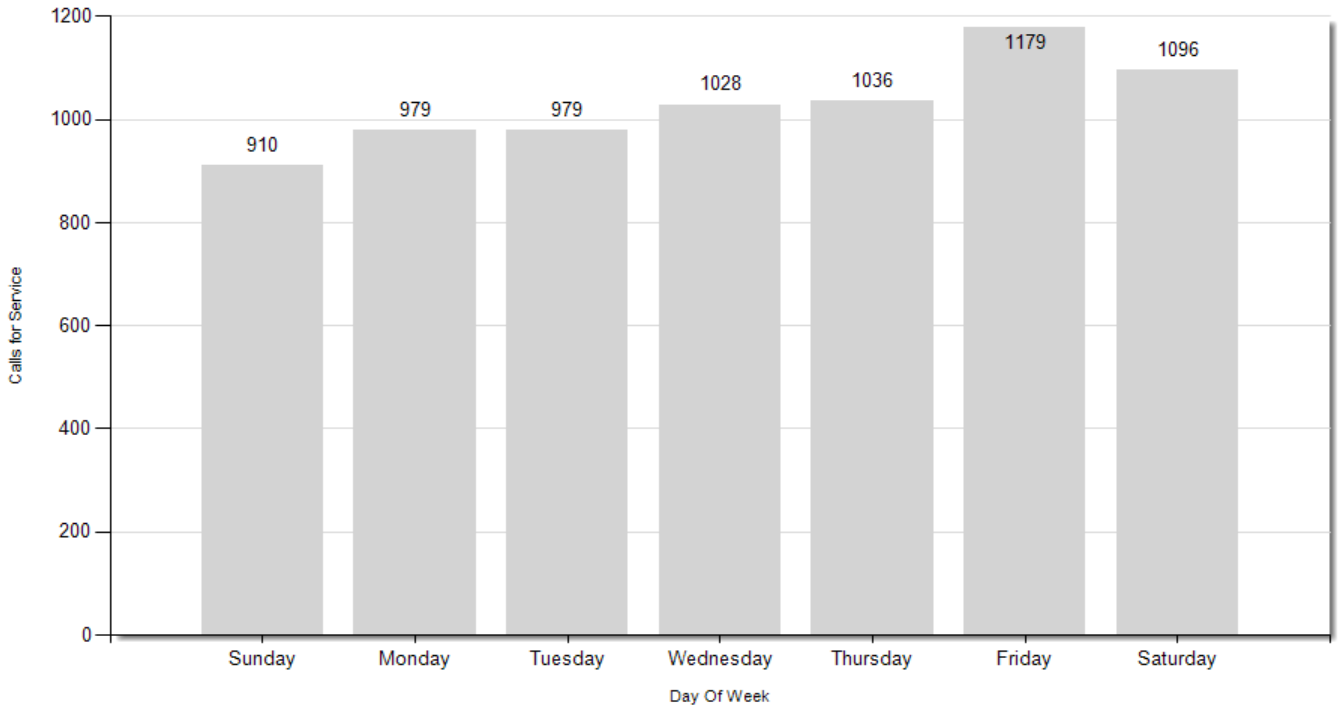

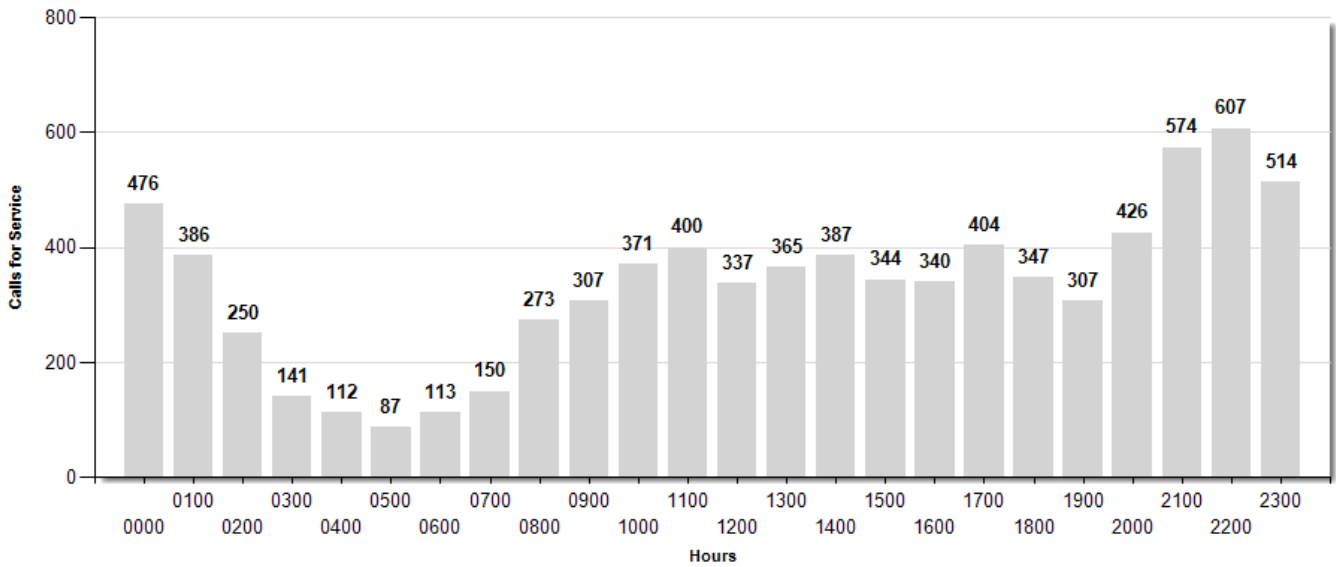

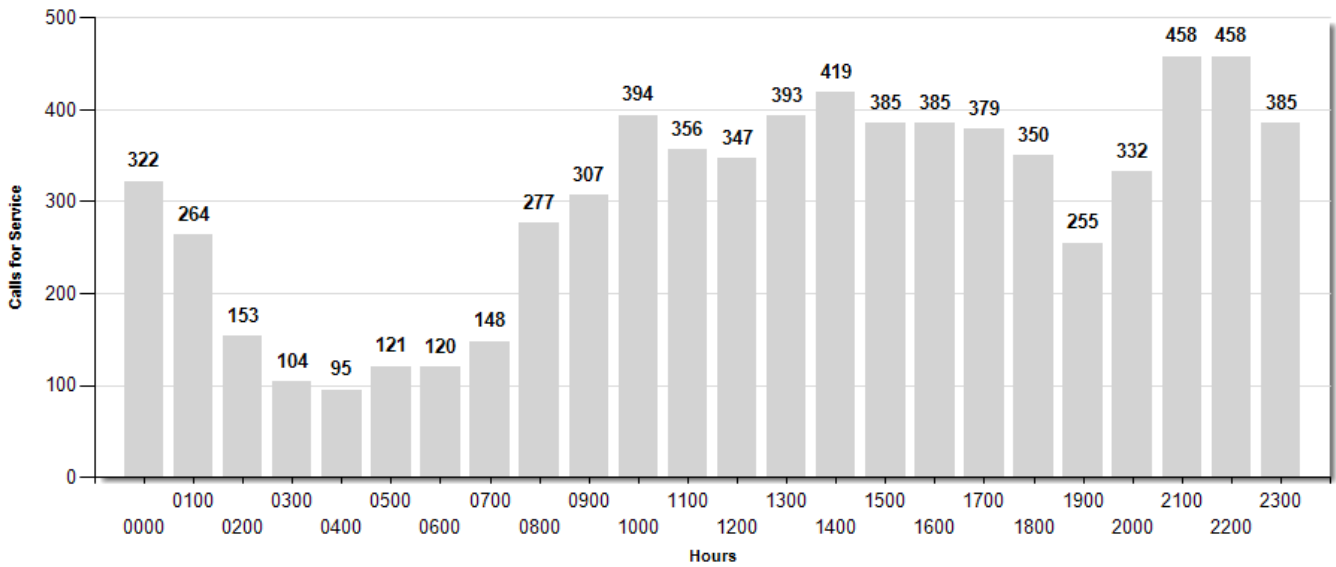


Calls for Service Hourly

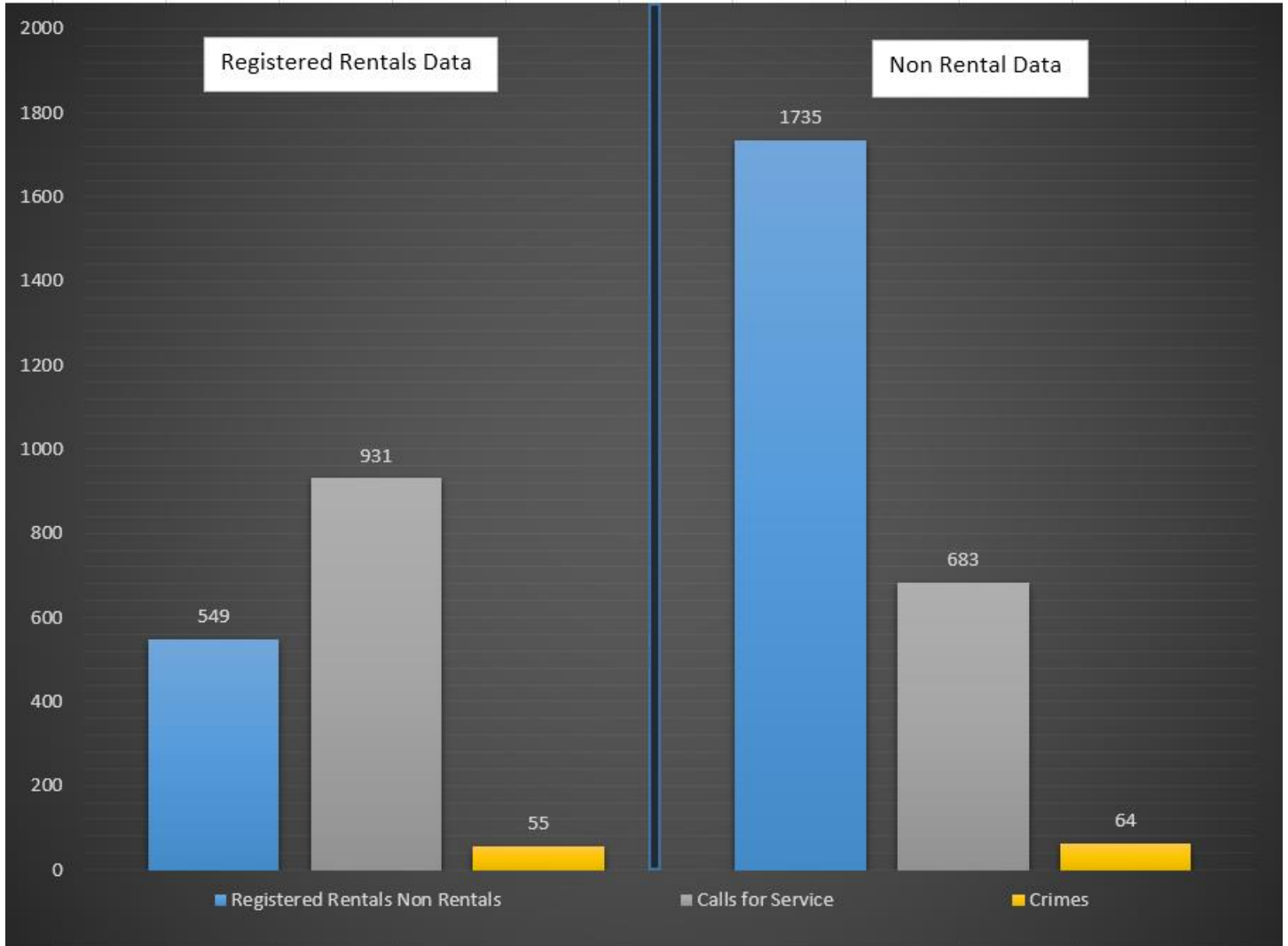




Crime Free Multi-Housing Statistics
